Minutes Animal Control Advisory Board Meeting February 17, 2005 Room 188, Capitol Annex Frankfort, Kentucky 40601

Board Members Present: Beckey Reiter, Dr. Linda Grimes, Elba Neat, Larry Hurt, Margie Patton, Judy Cooke, Judge John Settles, Rick Smith, and Dr. Heidi Shipman.

Board Members Absent: Eric Blow, Mary Beth Hendricks, and Anne Wilson.

Others Present: Mark Farrow, Dr. Sue Billings, and Ann Stewart, Department of Agriculture.

Ms. Reiter called the meeting to order. Minutes of the previous meeting were approved following motion made by Ms. Patton with second by Judge Settles.

Old Business: After several attempts to communicate with Martin County Judge/Executive concerning complaints about the animal shelter, the Board authorized the Department to initiate legal action for reimbursement of grant funds awarded for construction of an animal shelter.

Spay/Neuter: Ms. Cooke and Ms. Patton gave a summary of the pilot programs for distributing spay/neuter funds: direct distribution to individuals, and (2) distribution via intermediary organization (i.e., non-profit). (Sample applications for each program were distributed to members.) \$227,000 has been collected from the sale and renewal of spay/neuter license plates to date. Following a lengthy discussion of the proposed programs, Dr. Grimes moved to earmark \$100,000 to be used for grants to organizations, counties, and non-profit organizations for spay/neuter pilots programs and that the funds be available for distribution, pending approval of applications, on July 1, 2005. Second was made by Ms. Cooke, motion passed. Dr. Grimes also moved to earmark \$100,000 to be used for an individual-low income spay/neuter voucher program; seconded by Ms. Patton. Issue was tabled for further discussion at later meeting(s).

Training: Establishment of in-state training was discussed. Ms. Reiter advised that the Board must submit the curriculum to the Kentucky Board of Examiners for approval before program can be put into effect. Doug Fakkema has agreed to write the curriculum for Kentucky training and educate trainers, but he will first need to be approved as a sole source by Finance Cabinet. Dr. Grimes will advise of Dr. Fakkema's qualifications and fees to be used in preparing request to Finance Cabinet.

Ms. Reiter reported on her inspection of the Grant County animal shelter. Other than overcrowding, she saw no problems. The Board received a complaint concerning the Gallatin County Animal Shelter. Ms. Reiter will visit and inspect the animal shelter.

Ms. Reiter called the meeting to order. Minutes of the previous meeting were approved upon motion of Mr. Smith and second by Ms. Cooke. The next order of business was the election of Chairman. Ms. Reiter was elected to serve another term as Chairman.

Old Business --

Spay/Neuter License Plate Program: The program will be called Spay/Neuter Kentucky. Ms. Cooke and Ms. Patton discussed changes made to pilot programs (and forms) for the spay/neuter program. The voucher program will require that the pet owner pay a co-payment and have the pet vaccinated for rabies at the time of the spay/neuter. It was also decided that veterinarians would not be paid additional fees for pregnant dogs or dogs in heat. Following a phone conference with Glenn Mitchell, Executive Director, SPA, the Board made the decision to contract with private veterinarians in conjunction with the Department in its contract for Johne's testing. This would apply to the program for individuals. The Board will award monies to counties or organizations through grant agreements. A committee was established to review grant applications for spay/neuter funds and make recommendations to the Board regarding approval/denial. Members are: Ms. Cooke, Ms. Patton, Dr. Grimes, and Mr. Smith. Grants to organizations and counties will be limited to \$5,000.

Training: The Board would like to obtain sole source approval for Doug Fakkema to write curriculum for a state training program. Dr. Grimes provided information to prepare letter for Finance Cabinet. The Board hopes to hold 2-day training programs at least twice a year.

Gallatin County: Ms. Reiter visited the Gallatin County Animal Shelter and found several problems. She will visit the shelter again in a month to ensure corrections have been made.

Ms. Reiter advised the Board that the Fish and Wildlife Department is proposing changes to regulations which would prohibit owning exotic (dangerous) animals and had asked for the Board's support. It was agreed that members would prepare individual letters regarding their stance on the proposed changes.

Budget: Mr. Farrow reported that the budget passed during the 2005 general assembly did not contain appropriation for construction/renovation funds, so the earliest the Board will have additional funds is July 1, 2006. A request for \$2 million per biennium will be included in the Department's budget for 2006-2007. \$70,000 was appropriated for equipment, training, and administrative costs. \$140,000 from the livestock fund has been transferred to the Animal Care and Control Fund.

New Business: None

Mr. Neat moved for adjournment; motion seconded by Ms. Patton. Motion passed. Meeting adjourned.

FYI: According to Glenn Mitchell, the balance of the construction/renovation funds is \$551,601, as of March 24, 2005. (This total does not reflect grants approved at March 24, 2005, meeting.)

Ms. Reiter called the meeting to order. The motion to approve minutes of the June 3, 2003, meeting was made and seconded by Ms. Cook and Dr. Grimes, respectively. Motion passed.

Old Business:

Equipment Grants: Twenty-six counties have submitted invoices for reimbursement and checks have been mailed. We have 28 counties who have not submitted invoices for payment.

Spay/Neuter License Plate: As of September 17, 1771 spay/neuter plates had been sold.

Ms. Lyon requested the Board consider counties without shelters when distributing spay/neuter funds and suggested that local veterinarians receive funds on behalf of the counties. She stated that she and her husband had been "fostering" dogs for some time and that a shelter in Adair County was badly needed. Ms. Cooke suggested that GROWL apply for private funds to start a shelter and will provide names and addresses of organizations she should contact. Ms. Reiter advised that the Board would be discussing the structure of the spay/neuter program in the next few months and would consider the poor counties when establishing the guidelines of the program.

The Board next discussed grants for construction and renovation. The Board was allotted \$1.6 million dollars to disburse over the next 3 years. Funds are now available and applications will be sent to the county judges next week. Minor changes were made to the application form and approved by the Board. Mr. Tanner asked if favorable consideration would be given to counties whose match was more than the required 20 percent. The Board agreed and will give "extra points" when a match of more than 20 percent is made by the applicant. The Board decided on a December 31, 2003, deadline for receiving grant applications. Mr. Farrow suggested that the applications be scrutinized more thoroughly than in the past.

<u>Shelter Improvements Committee:</u> Ms. Reiter received information from the Humane Society of the United States which listed recommendations for building and operating an animal shelter. The packet was supplied to Board members and will be mailed to county judges with grant applications.

Kentucky Association of Counties Meeting: The annual meeting will be held November 19-21, 2003. The Board discussed attendance at the KACO meeting. Dr. Grimes moved that the Board attend the conference and sponsor a booth at a cost of \$400, her motion was seconded by Ms. Willson and the motion passed. Ms. Reiter will attend and asked for volunteers to man the booth during the 3-day conference--Dr. Grimes volunteered to work in the booth for a day. Mr. Farrow stated that convention would be a good time to advise county judges of legislation that would assist their counties in building and operating animal shelters. The meeting would also be a good opportunity to ask for their support of the bill and request that they contact and urge their legislators to vote for the bill. Mr. Smith will contact the president of the association about having a member of the Board on the convention program.

<u>Training:</u> Mr. Farrow is preparing a contract for two sessions of euthanasia by injection training, with sessions to be held before June 30. Ms. Reiter advised that she talked with Eric Blow about the possibility of developing an in-state certification training program similar to the NACA Level I training. If this program is established, in-state personnel could be used to conduct the training, it would no longer necessary to limit the number of attendees, travel expenses would be

reduced, it would be more convenient for county employees to attend, and the costs of the training could be customized depending on the counties' needs. She is also talking with University of Louisville officials concerning giving CEU credits for the training.

Legislation: The Board agreed to resubmit the bill introduced during the 2003 session of the General Assembly. Mr. Farrow stated that Senator Buford has agreed to sponsor the bill in the Senate. Ms. Reiter will talk with Senator Roeding concerning co-sponsoring, and Mr. Smith will contact Senator Palmer concerning possible support and co-sponsorship. Representative Thomas has agreed to sponsor the legislation in the House.

<u>New Business:</u> Although not discussed during the meeting, Dr. Haines submitted his resignation from the Board to Governor Patton. He is now residing in Louisiana.

Next Meeting: The next meeting is scheduled for October 6, 2005, at 10 a.m.

Motion to adjourn was made and seconded by Ms. Willson and Ms. Cooke. Motion passed. Meeting adjourned.

In Chair Becky Reiter's absence, Rick Smith welcomed Board members and guests. Motion made that minutes from the previous meeting be approved as amended. Motion passed.

The Spay/Neuter Kentucky Committee made a unanimous recommendation for 31 non-profit 501C counties to receive grants for the spay/neuter program.

Ms. Reiter arrived and proceeded to chair the meeting.

Dr. Linda Grimes reported on the euthanasia program. Dr. Grimes stated the need to extend the grant for Dr. Fakkema to conduct the state training programs. Nicole Liberto informed the Board that Dr. Fakkema's previous grant cannot be extended; and he cannot begin a training program until the RFP process has been completed and a program description has been approved by the Finance Cabinet.

Motion was made by Judy Cooke to award construction grants to Campbell County in the amount of \$20,000, to Muhlenberg County in the amount of \$80,000; to Marion County in the amount of \$21,492; and the Pennyrile Area in the amount of \$116,384. Motion was seconded by Anne Willson. Motion passed.

Members updated the Board on issues and events pertinent to their respective areas.

There is \$40,000 available for equipment grants for animal shelters. Each county may apply to receive up to \$1,000 for shelter equipment. Letters and applications will be sent to all county judges. The deadline for applying for the equipment grants is December 31, 2005. A motion to award these grants was made by Dr. Grimes and seconded by Wayne Caudill. Motion passed.

The next meeting is scheduled for January 12, 06, 2005, at 10 am, 107 Corporate Drive.

Motion to adjourn was made by Ms. Cooke and seconded by Mr. Caudill. Motion passed. Meeting adjourned.
